papers, student theses, and faculty research publications accessible to the public through the university website.

External researchers, community members, and school students are often allowed to use library facilities for academic purposes with prior approval.



This Memorandum of Understanding (MOU) is made on this **20th May 2024**, by and between **Lincoln University College**, an institution committed to advancing education and accessibility, and **uLearna.com**, an online learning platform dedicated to promoting lifelong learning opportunities. This MOU outlines the collaboration between both parties to provide public access to educational resources, including online courses and lectures, for individuals not currently studying at Lincoln University College.

1. Provision of Educational Resources for Non-Students

Lincoln University College and uLearna.com agree to collaborate in offering **educational resources to the general public**. This initiative aims to promote lifelong learning by making a wide range of courses and lectures available to individuals beyond the enrolled student body. Available resources will include:

2. Free Access to Educational Resources

4. Implementation and Access Management

uLearna.com will host the platform for accessing both free and charged educational resources, ensuring that:

- The **user interface is accessible** and user-friendly.
- Appropriate **technical support** is available to manage access and troubleshoot issues.
- Clear guidelines are established for accessing both free and charged resources.

5. Data Sharing and Privacy Compliance

Both parties agree to adhere to data protection laws and ensure that any **user data** collected in the course of this partnership is kept secure and confidential. Information about access patterns, course completion, and other relevant metrics will be shared only in aggregate form for reporting and improvement purposes.

6. Promotion of the Initiative

Lincoln University College and uLearna.com will jointly promote these educational resources through **social media**, **websites**, **and public relations channels** to maximize public awareness and participation in lifelong learning opportunities.

7. Duration of the MOU

This MOU is effective from the date of signing and will remain in effect for **5 years**, after which it may be renewed or amended upon mutual agreement of both parties.

8. Amendments

Any amendments to this MOU must be made in writing and signed by authorized representatives of Lincoln University College and uLearna.com.

9. Dispute Resolution

Any disputes arising from this MOU will be resolved through mutual discussions. If a resolution cannot be reached, the dispute may be referred to arbitration under applicable laws.

- Clear guidelines are set for resource availability and usage.

4. Data Sharing and Privacy Compliance

Both parties will adhere to data protection laws, ensuring that all user data remains secure

and confidential. Shared information will be anonymized and provided only in aggregate form for improvement and reporting.

5. Promotion of the Initiative

Lincoln University College and SPMPortal will promote these resources through **digital channels and public awareness campaigns** to maximize participation and resource utilization.

6. Duration of the MOU

This MOU is effective from the date of signing and will remain in effect for **3 years**, after which it may be renewed or amended by mutual agreement of both parties.

7. Amendments

Amendments to this MOU must be made in writing and signed by authorized representatives from Lincoln University College and SPMPortal.

8. Dispute Resolution

In the event of a dispute, both parties agree to resolve it through mutual discussions, with the option to proceed to arbitration if necessary, following applicable laws.
